Regis has been working in the parking business sector for more than 33 years: he was DESIGNA FRANCE's Technical Director for 15 years, and spent 7 years working for SKIDATA France as their local Products and Solutions Manager.

He followed several key projects such as the Year 2000 challenge or the transition to the euro money for more than 400 information systems.

He also participated in parking integration into several complex IT projects, by setting up the Taxis access control regulation at Paris Airports, in strong collaboration as access control expert with Sopra-Steria, by the integration of credit or private cards at payment machines in parking areas or the first French integration of license plate recognition in 2010 when it came to access management.

In 2014, he started his own company, Rex Pastore Consulting, dedicated to technical studies so that he could offer his expertise to others in the field. As a European technical expert in access control systems and innovative payment techniques, he takes part in intricate projects as a consultant for local authorities or private companies, either in France, in Italy, Belgium or Germany.

From 2015 to end 2018, he was also president of the Electronic Payment Commission at the Fédération Nationale des Métiers du Stationnement (FNMS)
